# **EMERGENCY ACCESS:**

Emergency Services staff provide crisis counseling or immediate evaluation for any child or adult experiencing a mental health crisis 24 hours a day, 7 days a week. We offer suicide assessment and examination for involuntary psychiatric admission for crisis stabilization care. PEMHS is the designated public receiving facility for Pinellas County. No person eligible for service under Florida's Baker Act is denied treatment.

#### **Crisis Stabilization**

Persons who are evaluated in Emergency Services are eligible for admission for Crisis Stabilization if they meet the criteria of Florida's Baker Act. The Baker Act is Florida's civil commitment statute that authorizes a person to be held up to 72 hours if they meet criteria which includes:

1 Mental illness

2. Poses a threat of harm to self or others without treatment

While a patient on the crisis unit, professional psychiatric care and treatment are provided. When the crisis has been alleviated, patients are referred to community support and most likely out-patient services.

Emergency Access to crisis intervention can be obtained 24 hours a day, 7 days a week at 11254 58th Street North, Pinellas Park 33782. Florida

PEMHS is located off of U.S. 19. behind Windmoor Hospital. South of the light at 118th Avenue (Bryan Dairy Road extension)

Crisis Stabilization Units for Adults are located at 11254 58th Street North. Pinellas Park. FL

The Crisis Stabilization Unit for Children (CSSU) is located at 11254 58th Street North, Pinellas Park, FL., All admissions to the Children's Unit must go through Emergency Access.

### **IMPACT Team**

The Impact Team is a group of professionals dedicated to crisis intervention and diversion. The team addresses the overall well-being of adults suffering from co-occurring disorders through assessment, safety planning, individualized service planning and linkage with resources designed to improve their quality of life. Eligibility for these services is generally adults who have been discharged from a Crisis Stabilization Unit within the last 30 days. Also, adults with a history of, current, or pending admission to a Crisis Stabilization Unit and with a primary diagnosis of mental illness and/or co-occurring disorder. Goals are to:

- · Reduce the number of Inpatient Crisis Stabilization Treatment admissions
- Provide supportive mental health services in the least restricted setting
- · Provide rapid solution focused services to reduce and prevent crisis situations
- · Connect individuals with long-term services that promote a pathway to a sustainable stable life and selfsufficiency
